



We are a leading provider of hydraulic lifting and haulage services primarily to the marine, petrochemical, and construction industries in Singapore. In addition, we also derive significant income from the trading of lifting and haulage equipment.

From a single 10 tonne mobile crane in 1980, we have expanded our combined lifting fleet and haulage fleet size to an aggregate of 230 vehicles as at 30 December 2009, consisting of 115 cranes (with lifting capacities ranging from 10 to 800 tonnes) and 115 units of haulage equipment. We offer the largest range of lifting capabilities in the hydraulic mobile crane category and we believe that we are the only company in Singapore able to provide mobile hydraulic lifting services with lifting capacities exceeding 500 tonnes.





**REVENUE** 


FY: Year ended 31 December
